4.1 December 15th Letter from the Governor Regarding Illegal School Fees

Mr. Woods reported that a recent lawsuit filed in Southern California addressed the issue of schools illegally charging students mandatory fees for participating in school activities. The letter from the Governor encourages schools to review their policies on school fees and revise if needed.

4.2 Medi-Cal Program Mid-Year Report

The Medi-Cal Administrative Activities (MAA) program reimburses school districts for the cost of linking students to Medi-Cal insurance and covered services. The report detailed funding reimbursed to Monson-Sultana JUESD for the current year and all previous years of participation in the program.

5.1 ADA - 5th Attendance Reporting Period

ADA for the 5th attendance reporting period was 418. This was an increase of 20 over the same period in 2009-2010.

5.2 IPD Green Process Report Mr. Frank Murphy of Indoor Environmental Services (IES) presented a proposal whereby IES would install and maintain a solar power generating station on school grounds. A preliminary study was previously approved and funded in FY 09-10 and in order to complete the solar portion of the survey, Mr. Murphy requested authorization of the final stage of the study which will be completed at no cost to the district.

5.3 Highway Patrol Safety Compliance Report The MOT Department recently underwent a review by the Highway Patrol. The inspection covered maintenance of records, vehicle examination reports for each bus, drug testing results, and a carrier inspection. An overall rating of "Satisfactory" was given which is the highest certification awarded for such inspections. Mr. Woods praised the efforts of MOT Director Brandon Corcoran and his staff for their hard work.
