There have been many community and stakeholder engagement opportunities during the 2020-2021 school year to gather and streamline feedback to inform the development of the Exp[anded Learning Opportunities Grant (ELOGP) and the Local Control and Accountability Plan (LCAP). The extensive feedback from the ELOGP and LCAP was used in the development of this ESSER III Expenditure Plan. Community engagement opportunities throughout the 2020-2021 school year targeted the following stakeholder groups: students, parents/guardians, school and district administrators, teachers, classified staff, ELAC/DELAC, parent/guardians of students with disabilities, students experiencing homelessness, and students in foster care. The District met with both bargaining units, School Site Council, and ELAC. The platforms used to solicit this input include: family and staff surveys using Google Forms, virtual community forums, student achievement data analysis meetings/dialogue ti identify students in need of academic or social-emotional supports. In addition, at a special meeting of the Monson-Sultana JUESD Board of Trustees, the Board will consider adoption of the ESSER III Plan and the opportunity for comment on the

plan. Throughout the process, their has been common concensus and agreement on the major actions/services for the ESSER III Expenditure Plan.

Feedback from the community stakeholder engagement strategies described above was incorporated into the development of the specific strategies for addressing the loss of instructional time and providing supplemental instruction and support to identified students. Additional feedback from the ELOGP and the LCAP remained consistent with current feedback, inluding a committment to in-person learning, small group support for reading, writing, and math, counseling support and interventions, student interventions, enrichment opportunities, and summer learning opportunities. The largest concensus was in support of construction of a Student Educational and Activity Center. The services and opportunities for students as described in the ESSER III plan incorporate this feedback and continues to build upon the ELOGP and LCAP goals of supporting safe and continuous in-person learning and addressing the academic, social, emotional, and mental health needs of all students.
